An Ordinance to amend the Grafton Diocesan Governance Ordinance 2008 relating to the change of name of the Grafton Diocese Investment Fund to Anglican Funds Grafton Diocese.

PREAMBLE

<u>WHEREAS</u> presently the Grafton Diocese Investment Fund is referred to throughout the Grafton Diocesan Governance Ordinance 2008 <u>AND WHEREAS</u> it is desirable to have the Ordinance amended to reflect the change of name of such to Anglican Funds Grafton Diocese <u>THEREFORE</u> the Bishop, Clergy and Laity of the Diocese of Grafton decree and enact as follows:

AMENDMENT

- Wherever the words "Grafton Diocese Investment Fund" occur to name the Fund in clauses of the Grafton Diocesan Governance Ordinance listed in Schedule 1 to this Ordinance, the clause is amended by deleting such words and substituting in place thereof the words "Anglican Funds Grafton Diocese".
- 2. Wherever the initials "GDIF" occur to name the Fund in clauses of the Grafton Diocesan Governance Ordinance listed in Schedule 2 to this Ordinance, the clause is amended by deleting such initials and substituting in place thereof the initials "AFGD".
- 3. This Ordinance may be cited as The Grafton Diocesan Governance Ordinance 2008 Amending (Grafton Diocese Investment Fund Name Change) Ordinance 2013
- 4. This Ordinance shall come into effect upon receiving the assent of the Bishop.
