CONSTITUTION AMENDMENT (MEMBERSHIP OF THE PROVINCIAL TRIBUNAL) CANON 2014 ASSENTING ORDINANCE 2015 Ordinance No. 19 of 2015

An Ordinance to assent to an amendment to the Constitution of the Anglican Church of Australia regarding membership of the Provincial Tribunal as approved by the Sixteenth Session of General Synod.

PREAMBLE

Whereas amendments to the Constitution of the Anglican Church of Australia require the assent of its constituent dioceses; and

Whereas it is desirable to have the Constitution of the Anglican Church of Australia amended;

Therefore, the Bishop, Clergy and Laity of the Diocese of Grafton, assembled as the Synod, decree and enact as follows:

ASSENT BY THE SYNOD OF GRAFTON

The Diocese of Grafton assents to the Constitutional Amendment (Membership of the Provincial Tribunal) Canon 2014 which was Canon 05, 2014 of the Sixteenth Session of the General Synod of the Anglican Church of Australia and set out in the Schedule hereto.

COMMENCEMENT

This Ordinance shall come into effect upon receiving the assent of the Bishop.

SHORT TITLE

This Ordinance may be cited as Constitution Amendment (Provincial Tribunal) Assenting Ordinance 2015.

A CANON TO AMEND SECTION 55 OF THE CONSTITUTION WITH RESPECT TO MEMBERSHIP OF THE PROVINCIAL TRIBUNAL

The General Synod prescribes as follows:

Title

This Canon may be cited as the Constitution Amendment (Membership of the Provincial Tribunal) Canon 2014.

Commencement

This Canon comes into effect on a date appointed by the President in accordance with section 67(2) of the Constitution.

Membership of the Provincial Tribunal

- In the first paragraph of section 55(1) of the Constitution, delete the matter "the metropolitan, or a deputy president appointed by him" and insert instead the words "appointed by the metropolitan".
- After the first paragraph of section 55(1) of the Constitution, insert the following paragraph:

"The metropolitan and any other bishop of the province is ineligible to be a member of the provincial tribunal. A person who is a member of the provincial tribunal shall cease to hold that office on becoming the metropolitan or other bishop of a diocese of the province."

- 5 In the second paragraph of section 55(1) of the Constitution:
 - (a) insert the following sentence at the beginning of the paragraph:

"The president shall be a person qualified to be a lay member of the Appellate Tribunal in accordance with the provisions of s.57(1) of this Constitution and will cease to hold office as prescribed by ordinance of the synod of the province", and

(b) delete the words "or deputy president".
