ASSENTING ORDINANCE 1993

AN ORDINANCE

To assent to the Constitution Alteration (Miscellaneous Sections)
Canon 1992 being a General Synod Canon to alter Miscellaneous
sections of the Constitution.

PREAMBLE

WHEREAS it is desirable that the Constitution Alteration
(Miscellaneous Sections) Canon 1992 of the General Synod of the
Anglican Church of Australia should be assented to the Diocese of
Grafton.

THEREFORE the Bishop, Clergy and Laity of the Diocese of Grafton
in Synod assembled decree and enact as follows:

SHORT TITLE

1. This Ordinance may be cited as the 'Constitution
Alteration (Miscellaneous Sections) Canon 1992, Assenting
Ordinance 1993.'

ASSENT

2. The Constitution Alteration (Miscellaneous Sections) Canon
1992 as set out in the Schedule hereto is hereby assented
to.

THE SCHEDULE

CANON No. 14, 1992

A canon to alter miscellaneous sections of the Constitution

The General Synod prescribes as follows:

1. This canon may be cited as "Constitution Alteration (Miscellaneous Sections)
Canon 1992".
2. The Constitution is altered to the extent provided in the Schedules to this canon.

- 3. (1) The alterations to the Constitution made by Schedules One and Two to this canon shall come into force on a date to be appointed and declared by the Primate who shall follow the procedure in Rule XX.
- (2) The alterations to the Constitution made by Schedule Three to this canon shall come into effect on a date determined by the General Synod by resolution passed after all assents required by section 67(1)(d) have been given and are in force at the same time.

SCHEDULE ONE

- 1. In section 17(6) substitute "eighteen" for "twenty-one".
- 2. In the definition of "Parishioner" in section 74(1) substitute "eighteen" for "twenty-one".

SCHEDULE TWO

In the last sentence of section 57(1):

- (a) substitute "State or Territory of Australia or a Justice or Judge of a Court prescribed by canon of the General Synod or is or has been" for "State, or", and
- (b) insert "or Territory" after "State" where secondly appearing.

SCHEDULE THREE

- 1. Delete from section 17(5):
"a missionary diocese or".
- 2. Delete paragraph 44(1)(d) and substitute a full stop for the semi-colon at the end of paragraph 44(1)(c).
- 3. Delete from section 49:
"a missionary diocese or in".
- 4. Delete the definition of "Missionary diocese" in section 74(1).


