LISMORE PARISH CENTRE PRESCHOOL (AMENDMENT) ORDINANCE 1990

An Ordinance to correct inconsistencies in the naming of the Management Committee in the Lismore Parish Centre Preschool Constitution Ordinance 1989 and the Lismore Parish Centre Preschool Committee of Management Incorporation Ordinance 1989.

PREAMBLE

WHEREAS in the Lismore Parish Centre Preschool Constitution Ordinance 1989 and the Lismore Parish Centre Preschool Committee of Management Incorporation Ordinance 1989 the committee is variously named the Committee of Management and Management Committee

AND WHEREAS in the Constitution of the said Lismore Parish Centre Preschool the committee is named the Management Committee and it is desirable that the same name be used in the above Ordinances

AND WHEREAS by the provisions of the Anglican Church of Australia (Bodies Corporate) Act and the Bodies Corporate (Delegation of Powers) Ordinance 1988 the Bishop-in-Council is empowered during the recess of Synod to exercise certain powers and such recess now exists;

THEREFORE the Bishop-in-Council in pursuance of such powers and in the name of Synod hereby ordains declares directs and rules as follows:-

AMENDMENT

- 1. In the Lismore Parish Centre Preschool Constitution Ordinance 1989 the heading to Section 1 is amended to read "CONSTITUTION OF THE MANAGEMENT COMMITTEE OF THE PRESCHOOL"
2. In the Lismore Parish Centre Preschool Committee of Management Incorporation Ordinance 1989 in the Title, Preamble, Section 1 and Section 2 the words "Management Committee" are substituted for "Committee of Management" wheresoever occurring.

SHORT TITLES

- 3. This Ordinance may be cited as the Lismore Parish Centre Preschool (Amendment) Ordinance 1990.
4. The Lismore Parish Centre Preschool Constitution Ordinance 1989 as amended by this Ordinance may be cited as the Lismore Parish Centre Preschool Constitution Ordinance 1989 - 1990.
5. The Lismore Parish Centre Preschool Committee of Management Incorporation Ordinance 1989 as amended by this Ordinance may be cited as the Lismore Parish Centre Preschool Management Committee Incorporation Ordinance 1989 - 1990.
6. This Ordinance shall come into effect upon receiving the assent of the Bishop.
