# FRIENDS OF THE LITTLE BROTHERS OF FRANCIS CONSTITUTION ORDINANCE 2003

# ORDINANCE NO 03OF 2003

AN ORDINANCE to provide for the constitution of the "FRIENDS OF THE LITTLE BROTHERS OF FRANCIS" and matters incidental thereto.

#### **PREAMBLE**

WHEREAS it is desirable that a Constitution be provided for the good government and management of the said Friends of the Little Brothers of Francis;

AND WHEREAS by the provisions of The Anglican Church of Australia (Bodies Corporate) Act 1938 and the Bodies Corporate (Delegation of Powers) Ordinance 1988 the Bishop-in-Council is empowered during the recess of Synod to exercise certain powers and such recess now exists;

THEREFORE the Bishop-in-Council in pursuance of such powers and in the name of the Synod hereby ordains declares directs and rules as follows:

#### CONSTITUTION OF THE FRIENDS OF THE LITTLE BROTHERS OF FRANCIS

- 1: It is expedient for the purpose of managing, governing, and controlling the said Friends of The Little Borthers of Francis that the persons who are appointed by the Chapter of the Little Brothers of Francis shall be the members of the Original Committee of Management until the 30<sup>th</sup> September 2005 and/or until such time as appointments to the Committee are made or required under the Constitution.
- 2. The affairs of the Friends of the Little Brothers of Francis shall be conducted in accordance with the Constitution contained in the Schedule hereunder.

#### SHORT TITLE

- 3. This Ordinance may be cited as the "Friends of the Little Brothers of Francis Constitution Ordinance 2003".
- 4. This Ordinance shall come into effect upon receiving the assent of the Bishop.

#### THE SCHEDULE

# CONSTITUTION Of FRIENDS OF THE LITTLE BROTHERS OF FRANCIS

In this Constitution the singular includes the plural and vice versa, and the masculine includes the feminine and vice versa, unless the context otherwise requires or indicates.

#### 1 - DEFINITIONS

- 1.1 "Act" means The Anglican Church of Australia (Bodies Corporate) Act 1938 of New South Wales as amended.
- 1.2 "Appendices" mean documents attached to, but not part of, this Constitution made, amended, replaced, or added to from time to time by the Chapter without needing the consent or approval of any other body.
- 1.3 "Bishop" means the Bishop of the Anglican Diocese of Grafton or his Commissary if he be absent from the State or the Administrator of the Diocese if the See be vacant.
- 1.4 "Bishop-in-Council" means the Bishop acting by and with the advice and consent of the Council of the Diocese of Grafton.
- 1.5 "Body Corporate" means the Body Corporate incorporated under the Act and refers to the Friends of the Little Brothers of Francis Incorporated.
- 1.6 "The Chapter' means a formal meeting of the Life-Professed Little Brothers of Francis, the signed minutes of which shall be conclusive evidence of the proceedings of that meeting.
- 1.7 "Financial Year" means the calendar year from 1 July to 30 June.
- 1.8 "Friends" or "The Friends" means the 'Friends of the Little Brothers of Francis Incorporated".
- 1.9 "Member of the Church" means a baptised person who attends the public worship of The Anglican Church of Australia and who declares that he or she is a member of that Church and is not a member of any other Church.
- 1.10 Members" means, unless the context indicates otherwise, Financial Members of the Friends of the little Brothers of Francis whose applications for membership have been approved by the Committee.
- 1.11 "Ordinance" means an ordinance of the Diocese of Grafton.
- 1.12 "Original Committee" means the first Committee appointed under the Ordinance and shall hold office until 30<sup>th</sup> SEPTEMBER 2005 and until/or such time as its successor is appointed under the provisions of this Constitution. On appointment, members of the Original Committee shall be deemed to be Financial Members of the Friends.
- 1.13 "Synod" means the Synod of the Anglican Diocese of Grafton.
- 1.14 The "Little Brothers of Francis" or the "Little Brothers" or "the Brothers" or "LBF" mean the Religious Order recognised within The Anglican Church of Australia by the authority of the Religious Life Advisory Council which advises the House of Bishops.

#### 2 - AIMS OF "THE FRIENDS"

The aims of the Body Corporate are:

- 2.1 To espouse the following principles:
  - (a) Friends are those who value and support the witness of the Contemplative Orders within the Church, and the Little Brothers of Francis in particular.
    - (1) They do this by developing their own prayer life and by supporting the Brothers in the following ways, as circumstances allow:
      - with prayerful support of the Brothers at "Eremophila", TABULAM and any other foundations that the Brothers may make;
      - joining them in the Liturgy of the Hours, using the LBF Offices where possible;
      - using the 'Prayer for Religious Life', on Fridays in union with the Brothers.
    - (2) They actively promote awareness of the Little Brothers of Francis.
    - (3) They actively witness to the ethos and values of the charism and spirituality of the Little Brothers of Francis.
    - (4) They support the Brothers with financial and practical help.
  - (b) Friends promote and encourage vocations to the Religious Life in the Church.
  - (c) Friends accept the principles of the Sources of Inspiration of the Little Brothers of Francis as underlying the ethos and values of the Little Brothers of Francis, as expressed in Appendix A, and will endeavour to support them.
- 2.2 To undertake works, activities, and fund-raising ventures, and to provide facilities and resources, for the benefit of the Little Brothers of Francis.
- 2.3 To develop opportunities for Friends for worship and prayer, to learn together, and to find fellowship with groups of Friends.
- 2.4 To support any other foundations established by the Brothers.
- To be the vehicle by which, in the event of the deaths of the Brothers, or in the event that the Chapter ceases to exist, property and assets, received by the Body Corporate by bequest, gift, or other means, may have provision made for the continuance of the ethos and values of the spirituality of the Brothers by endeavouring to encourage successors in the Religious Life or else, in the event of that project failing, disposing of the property and assets to appropriate bodies such as other Contemplative Orders with similar aims to the Brothers.
- 2.6 To do all such other things as are incidental or conducive to the attainment of the above aims.

#### 3 - THE COMMITTEE OF MANAGEMENT

The Committee of Management, hereinafter referred to as 'The Committee', shall be no more than five (5) persons, and shall consist of the following members:

- 3.1 The President;
- 3.2 The Vice-President;
- 3.3 The Honorary Secretary;
- 3.4 The Honorary Treasurer; and
- 3.5 One (1) Committee Member.

The Office-Bearers shall be the President the Vice-President the Secretary, and the Treasurer.

#### 4 - APPOINTMENT OF COMMITTEE

The Committee shall be appointed as follows:

- 4.1 The President shall be appointed by resolution of the Chapter.
- 4.2 The Vice-President shall be appointed by resolution of the Chapter, on the nomination of the President.
- 4.3 The remaining members of the Committee shall be appointed by the President with the consent of the Chapter.
- 4.4 The term of a member appointed shall be Three (3) Years, commencing from 1 November, provided that the initial appointees of the Original Committee shall hold office for the balance of the year prior to 30<sup>th</sup> September in the year of appointment in addition to the three year term that follows i.e. until 30<sup>th</sup> September 2005.
- 4.5
- (a) Members of the Committee shall be eligible for re-appointment and notwithstanding anything contained in this Constitution shall remain members of the Committee and continue to hold any office to which the members may have been appointed until the vacancy caused by the expiry of their term has been filled.
- (b) If there is no Chapter or a successor to that body, appointments and/or re appointments may be made by Bishop-in-Council on the recommendation of the Committee.
- 4.6 A casual vacancy shall occur if a member of the Committee
  - (a) dies;
  - (b) resigns in writing addressed to the President, or, in the case of the President, in writing addressed to the Chapter, and in such case shall, unless the writer specifies a later date, be deemed to be effective when the President or the Chapter (as the case may be) receives the written resignation:
  - (c) becomes bankrupt within the meaning of the law in force for the time being relating to bankrupts or if the member's affairs are compounded with creditors;

- (d) becomes of unsound mind or is a person whose person or estate is liable to be dealt with in any way under the law relating to mental health;
- (e) is convicted of an indictable offence;
- (f) is removed by a resolution of the Chapter who may do so without assigning any reason therefore.
- 4.7 A casual vacancy shall be filled in the same manner as prescribed in Clauses 4.1, 4.2, and 4.3 above.
- 4.8 A person who fills a casual vacancy shall hold office until the day on which the person whose vacancy was filled would have retired had the vacancy not occurred.
- 4.9 Members of the Friends may make representations to the Chapter or the President regarding appointments to the Committee,
- 4.10 The President and at least two other members of the Committee are to be members of the Church.

#### 5 - COMMITTEE MEETINGS

- 5.1 The Committee shall meet as often as required, provided that it meets at least three times a year.
- 5.2 Meetings of the Committee shall be convened by the President or by the Chapter, provided that seven days' notice is given to each member, unless there is urgent need to proceed with less notice.
- 5.3 The President shall preside at all meetings of the Committee; in the absence of the President the Vice-President shall preside; in the absence of both, the Committee shall elect one of the members then present or available to chair the meeting.
- 5.4 The quorum for a meeting of the Committee shall be three (3) members.
- 5.5 The President shall have both a deliberative and a casting vote at any meeting of the Committee. In the absence of the President and, in the event of an equality of votes, the matter shall be resolved in the negative,
- 5.6 Meetings of the Committee may take place by telephone or other electronic communication and/or by "Flying Minute", provided that a quorum is involved.
- 5.7 In the absence of the President through illness, leave, incapacity, or by casual vacancy, the Vice-President shall be the Acting President.

## 6 - DUTIES AND POWERS OF THE COMMITTEE

- The Friends as constituted by Ordinance and this Constitution shall be constituted as a Body Corporate under the Act by an enabling ordinance and shall enjoy and exercise the powers pertaining to a Body Corporate.
- 6.2 The Committee shall control, conduct govern, and manage the affairs of the Body Corporate in accordance with the provisions of any relevant Act of Parliament and this Constitution, and shall be responsible and accountable to the Chapter, provided that the Chapter is not liable for any debts and liabilities incurred by the Body Corporate.

- 6.3 The Committee shall pursue the aims of the Friends as stated in Clause 2 of this Constitution.
- 6.4 The Committee, subject to the provisions hereof, may regulate its own proceedings, and for that purpose it shall have power to make, rescind, or alter Regulations which are not inconsistent with this Constitution, provided that Chapter consent to such Regulations.
- 6.5 The Committee may authorise any person or persons to do any specified act on its behalf and may prescribe conditions for the exercise of the authorisation.
- 6.6 The Committee shall cause proper Minute Books to be kept of the proceedings of all its meetings. Minutes of a meeting confirmed at a subsequent meeting of the Committee and signed by the presiding member of that meeting shall be conclusive evidence of the passing of any resolution contained in the confirmed minutes.
- 6.7 SEAL: The Committee shall provide for the safe custody of the Common Seal of the Body Corporate which shall only be used by the authority of the Committee, and every instrument to which the seal is affixed shall be signed by any two members of the Committee. The seal shall be affixed over the signatures.
- The Committee shall determine the Policy of the Friends on any matter, thing, or issue whatsoever subject to and in accordance with the general policy and lawful directions of the Chapter where applicable to the Friends, and may delegate the administration of any policy to such person or persons as it may delegate.
- (a) The Committee may appoint sub-committees either specifically or generally, and may co-opt non-committee members to such sub committees;
  - (b) Such sub-committees shall perform such tasks as are specified by the Committee;
  - (c) The Committee shall determine the structure and composition of such sub-committees as well as the basis and guidelines on which such sub-committees shall operate.
- 6.10 The Committee shall manage the property and assets of the Body Corporate.
- 6.11 The Committee may, on behalf of the Body Corporate, solicit and/or accept real and personal property of any kind by way of gift, bequest, subsidy, or subvention as the Committee may think fit.
- 6.12 The Committee may sell, exchange, let, or otherwise dispose of or deal with any real or personal property of the Body Corporate, may invest and deal with money, and may enter into contracts on behalf of the Body Corporate.
- 6.13 The Committee may take on lease or hire any real or personal property or any rights or privileges which the Committee may think fit.
- 6.14 The Committee shall effect insurance against risks and for cover as is deemed appropriate or required by law from time to time.
- 6.15 Any acts of the Committee or of any of its Office-Bearers shall not be invalid by reason of any irregularity with respect to the appointment or constitution of the members of the Committee or any Office-Bearer.

6.16 The Committee is empowered generally to do all things necessary or expedient for the due and proper conduct of the affairs of the Body Corporate for which no specific provision is made in this Constitution.

#### 7 - FINANCE

- 7.1 The Committee shall cause true accounts to be kept of all moneys received and expended by the Friends, and of the assets and liabilities of the Friends.
- 7.2 The Financial Year of the Friends shall close on the Thirtieth day of June in each year.
- 7.3 There shall be placed before the Annual Meeting of the Chapter in September of each year an Income and Expenditure Statement of the Friends for the preceding Financial Year and a Balance Sheet as at the Thirtieth Day of June of that year. Such Financial Statements shall be accompanied by a report of the Treasurer and the Auditors. A copy of the Financial Statements shall be made available to each member of the Friends, the Visitor, Bishop-in-Council, and such other persons or bodies who are entitled to receive the Financial Statements. All records shall be kept for at least seven years after the end of the Financial Year to which they relate.
- 7.4 Auditors shall be appointed from time to time by the Committee. The Auditors shall make a report to the Chapter through the Committee on the Annual Financial Statements, and on other financial statements as may be required from time to time, either by the Committee or by the Chapter. The Auditors are to notify promptly the Chapter if they are of the opinion that communication with the Committee is inadequate regarding deficiencies in internal control, qualification of the Auditors' Report or any other matter, or if the Auditors have not signed a Report on accounts prepared pursuant to this Constitution within six months of the end of the Financial Year.
- 7.5 The assets and income of the Friends shall be applied solely in furtherance of the above-mentioned aims and no portion shall be distributed directly or indirectly to the members of the Friends except as bona-fide compensation for services rendered or expenses incurred on behalf of the Friends.
- The Bankers shall be appointed from time to time by the Committee and all cheques and withdrawal forms drawn on any account of the Friends shall be signed by any two of such persons as the Committee may from time to time determine. Each person so authorised shall be either a member of the Committee or of the Chapter. Accounts shall be opened and closed only with the authority of the Committee, which shall determine the names and styles of accounts.
- 7.7 The Committee shall determine by resolution the Annual Membership Subscription to be paid by members of the Friends by which they become or remain Financial Members for the Financial Year specified. A person who is unwaged or is a pensioner may pay a discounted Subscription as determined by the Committee from time to time.
- 7.8 The Committee may authorise or otherwise approve fund-raising activities for the benefit of the Little Brothers of Francis. Such fluids are to be accounted for through the books of the Friends as required by Clause 7. 1.
- 7.9 From time to time the Committee may authorise a levy of a reasonable amount on members of the Friends for a specific purpose.
- 7.10 The Committee shall be solely responsible for all liabilities incurred by it or on its behalf.
- 7.11 Every member of the Committee shall be indemnified out of the property of the Body Corporate for any loss or liability properly incurred by the Committee for which they may

become personally liable insofar as such liability was not incurred by reason of their misconduct or wilful default.

#### 8 - ANNUAL MEETINGS

8. Annually, the Committee through the President shall present to the Annual Meeting of the Chapter a report of the previous Financial Year's activities of the Friends and of the Committee, and report as to the state of affairs of the Friends. This report shall be submitted no later than 1' September in each year. A copy shall be made available to each member of the Friends, as well as to the Visitor and Bishop-in-Council.

#### 9 - MEMBERSHIP

- 9.1 A person may become a member of the Friends by the acceptance by the Committee of that person's application for membership on the prescribed Application Form, together with the appropriate Annual Subscription.
- 9.2 Only Financial Members may receive the privileges of membership.
- 9.3 A member may become a Fully-Paid-Up Member (FPUM) by paying an amount equivalent to Ten times the full Annual Subscription, and will not thereafter be liable to pay the Annual Subscription to be a Financial Member.
- 9.4 A person, at the absolute discretion of the Committee and with the consent of the Chapter, may be made an Honorary Member, with all the privileges of membership without the obligation of paying the Membership Subscription.
- 9.5 A person, at the absolute discretion of the Committee and with the consent of the Chapter, in recognition of services to the Friends or to the Little Brothers of Francis, may be honoured by being made an Honorary Life Member, with all the privileges of membership without the obligation of paying the Membership Subscription.
- 9.6 Until the Committee determines otherwise, the Annual Membership Subscription is Twenty Dollars (\$20), with the discounted Subscription being Ten Dollars (\$10).
- 9.7 Groups of Friends may meet together for prayer, worship, mutual support, and fellowship, and for works, fund-raising, and other activities for the benefit of the Brothers or to assist the aims of the Friends, subject to the policy or directions of the Committee.
- In the event of a member's activities or conduct being deemed by the Committee as bringing or likely to bring the Friends or the Brothers into disrepute such as to cause scandal, the Committee may in its absolute discretion resolve to cancel the member's membership or not to renew that person's membership, provided:
  - (a) that lawful criticism is not to be regarded as scandalous conduct;
  - (b) that notice in writing of the proposed action of the Committee is given in reasonable time to the member, who is entitled to offer reasons to the Committee as to why they should not proceed with the proposed action;
  - (c) that the decision is communicated in writing to the member, with the date of the decision being clearly indicated;
  - (d) that the former member has the right of appeal, within one (1) month of the effective date of cessation of membership, to the Chapter, whose decision shall be final.

#### 10 - VISITOR

10. The Official Visitor to the Body Corporate shall be the Bishop Protector of the Little Brothers of Francis for the time being, and there shall be vested in that person such powers and duties as usually pertain to the office of Visitor.

#### 11 - DISSOLUTION

- 11.1 The Body Corporate shall not be dissolved without the approval of the Chapter or at its direction. A resolution to that effect is to be duly passed at a Special Meeting of the Chapter, provided that notice in writing has been given to all Financial Members of the Friends not fewer than twenty-one days before the date of the meeting and provided that representations from the Friends or any of them may be made to the Chapter prior to that meeting. The Chapter shall take into account the opinion of the Committee before proceeding to such a resolution at the Special Meeting.
- 11.2 If there is no Chapter or a successor to that body, and the Committee considers it desirable to dissolve the Friends, then the Committee shall act as in Clause 11. 1 as if it were the Chapter.
- 11.3 The approval of the Bishop-in-Council is requisite to the dissolution of the Friends; the Ordinances relating to the Body Corporate shall be repealed by the Synod or Bishop-in-Council on the petition of the Chapter or its successor, or by the Committee if there is no Chapter or successor, provided that all the requirements of Clause 11.4 have been complied with.
- 11.4 In the event of the Body Corporate being wound up, any surplus assets remaining after the payment of the Friends' liabilities shall be transferred to another body attached to a Religious Contemplative Order with similar purposes which is not carried on for the purposes of profit or gain to its individual members, which is approved either by the Chapter or its successor, or by the Committee if there is no Chapter or successor.

#### 12 - ALTERATION TO CONSTITUTION

- 12. This Constitution shall not be amended except by a resolution passed at a Special Meeting of the Chapter called for that purpose, provided that:
  - (a) notice in writing in writing of the proposed amendment has been given to all members of the Friends not fewer than twenty-one days before the date of the Special Meeting;
  - (b) the proposed amendment is supported or proposed by the Committee or is at the absolute discretion of the Chapter;
  - (c) members of the Friends may make representations to the Chapter for its consideration prior to its making such a resolution; and
  - (d) the amendment to become affective shall require the approval of the Synod or Bishop-in-Council through the adoption of an appropriate Ordinance at the request of the Chapter.

#### LITTLE BROTHERS OF FRANCIS

#### Sources of Inspiration

We are a community of Brothers who desire to deepen our relationship with God through prayer, manual work, community, and times of being alone in our hermitages. We follow the Rule for Hermitages written by St Francis, in which three or four brothers live in each fraternity. As others join us, we envisage a federation of fraternities with three or four brothers in each.

There are four sources of inspiration for the Little Brothers of Francis. They are:

#### 1. The Gospels.

The four Gospels - Matthew, Mark, Luke, and John - are central to our spirituality, and are the main source material for our meditation and prayer life.

#### 2. St Francis.

Francis would recall Christ's words and life through persistent meditation on the Gospels, for his deep desire was to love Christ and live a Christ-centred life.

He was a man of prayer and mystic who sought places of solitude; hermitages played a central role in his life. Significant events, like the initiation of the Christmas Crib tradition, happened at the hermitage at Greccio, and, of course, he received the stigmata while he was at the hermitage at Mount la Verna - to mention just a couple.

Though the early brothers embraced a mixed life of prayer and ministry, Francis wanted places of seclusion - hermitages - for the primacy of prayer, in which three or four brothers lived, and for which he wrote a rule.

## 3. Saint Francis' Rule for Hermitages.:

In his brief rule for life within the hermitage, Francis avoids a detailed document, but sets out the principles that are important.

- 'Liturgy of the Hours' is the focus, and sets the rhythm of the daily prayer.
- ◆ Each hermitage was to have three or at the most, four Brothers, which meant that they would be both 'little' and 'fraternal'.
- Within this framework, Brothers could withdraw for periods of solitude.
- ◆ The hermitages were not to be places or centres of ministry.

#### 4. Desert Fathers.

The stories and sayings of the Desert Fathers contain a profound wisdom for any who are serious about the inner spiritual journey. This is why they have held such prominence in monastic circles in both the East and the West down through the centuries, and why they are a priority source for us.
