

Parochial (Amendment) Ordinance 1950

AN ORDINANCE.

To amend the Parochial Ordinance 1936 WHEREAS by an Ordinance of the Synod of the Diocese of Grafton passed in the year One thousand nine hundred and thirty-four it shall be the duty of the Bishop-in-Council to discharge all duties specifically assigned to it from time to time by the said Synod under resolution AND WHEREAS by a resolution of Synod passed on the twentieth day of September 1950 the Bishop-in-Council was authorised and requested to amend the existing ordinance in terms of this enactment NOW THEREFORE the Bishop-in-Council of the Synod of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the said Synod and the said Ordinance and in pursuance of the powers vested in the said Synod by the Constitution for the management and good government of the Church of England within the State of New South Wales in the name and in the place of such Synod ordains directs and rules as follows:—

SHORT TITLE.

1. (a) This Ordinance may be cited as the Parochial (Amendment) Ordinance 1950.
(b) The Parochial Ordinance 1936 is in this Ordinance referred to as the Principal Ordinance.
(c) The Principal Ordinance as amended by this Ordinance may be cited as "Parochial Ordinance 1936-1950."
