# CLERGY RELIEVING FUND ORDINANCE 1964

# AN ORDINANCE

To provide suitable relief for certain clergy who become temporarily incapacitated for normal duty.

# PREAMBLE

The Bishop the Clergy and the Laity of the Diocese of Grafton in Synod assembled declare ordain and enact as follows:

# SHORT TITLE.

1. This Ordinance may be cited as the Clergy Relieving Fund Ordinance 1964.

## RELIEF.

2. The Diocese may supply a clergyman to relieve the Minister of any Ecclesiastical District who is temporarily incapacitated.

# APPLICATION FOR RELIEF.

3. The Minister-in-Charge or the Churchwardens of any Ecclesiastical District requiring relief shall apply to the Bishop in writing giving full details of all relevant circumstances.

# GRANTING OF RELIEF.

4. The Bishop shall determine whether and for what period or periods relief is to be granted and shall arrange for the relief clergyman.

# ESTABLISHMENT OF FUND

5. There shall be a fund known as the Clergy Relieving Fund to which each Ecclesiastical District shall until otherwise determined by Smod contribute the sum of Ten pounds per annum in advance. Any surplus shall be carried forward each year and any deficiency shall be a charge on the general funds of the Diocese.

## PAYMENT FOR RELIEF.

# DATE OF COMMENCEMENT.

7. The said Fund shall be established by and relief shall be provided from the first day of January, 1965. Each Ecclesiastical District shall remit to the Registrar before that date Five pounds as its contribution for the second half of the current financial year.

### DATE OF COMMENCEMENT .

7. The said Fund shall be established by and relief shall be provided from the first day of January, 1965. Each Ecclesiastical District shall remit to the Registrar before that date Five pounds as its contribution for the second half of the current financial year.
