# THE LONG SERVICE LEAVE (AMENDMENT) CRDINANCE 1970

#### AN CRDINANCE

to adopt the Long Service Leave Canon Amendment Canon 1969 and to amend the Long Service Leave Ordinance 1968.

#### PREAMBLE

WHEREAS the Long Service Leave Canon 1966 has been amended by General Synod in 1969 AND WHEREAS it is expedient to adopt the Long Service Leave Canon Amendment Canon 1969 and it is desirable to amend the Long Service Leave Ordinance 1968 (hereinafter referred to as the Principal Ordinance) THEREFORE the Bishop Clergy and Laity of the Diocese of Grafton in Synod assembled declare ordain and enact as follows:-

## SHORT TITLE

This Ordinance may be cited as the "Long Service Leave Amendment Ordinance 1970".

#### ADCETION

The Long Service Leave Canon Amendment Canon 1969 contained in the Schedule hereto is hereby adopted and each reference in the Principal Ordinance to the Long Service Leave Canon 1966 shall be read and construed as a reference to the Long Service Leave Canon 1966-1969.

#### AMENDMENT

- Section 9 of the Principal Ordinance is amended by deleting the last sentence and inserting in lieu thereof the following sentence: "The taking of leave by a clergyman may be postponed to a date agreed to by himself and the Bishop-in-Council acting on behalf of the Diocese.
- In Sections 6, 8 and 12 of the Principal Ordinance the word "Clause" is deleted and the word "Section" substituted.
- Section 12 of the Principal Ordinance is amended by: 5.
  - deleting the word "three" and substituting the word "four".
  - deleting the words and figures "Parochial Ordinance 1936-50 Clause 45" and substituting the words and figures "Parochial Ordinance 1969 Section 58".

## THE SCHEDULE

# No. 3, of 1969

A CANON TO AMEND THE LONG SERVICE LEAVE CANON 1966.

WHEREAS it is expedient to amend the Long Service Leave Canon 1966 as hereinafter set out.

NCW the General Synod prescribes as follows:-

- The Long Service Leave Canon 1966 is in this Canon referred to as "the Principal Canon".
- This Canon may be cited as "Long Service Leave Canon Amendment Canon 2. 1969".
- The Principal Canon as amended by this Canon may be cited as the 3. "Long Service Leave Canon 1966-1969".

# Long Service Leave (Amendment) Ordinance 1970 (Continued)

- The principal Canon is amended -
  - (a) (i) by inserting in Section 7 after the symbol "7" the figure "(1)".
    - (ii) by inserting in the same Section next after sub-section (1) the following new sub-section: "(2) Where money becomes available in respect of the service of a clergyman by virtue of sub-section (1) of this section, the Board shall pay to the diocese in which that clergyman was . last serving a sum equal to so much of the notional annual stipend as is apportionable to the period of that leave and the diocese shall where the ordinary stipend of the clergyman had not been payable by the diocese itself remit that sum to the parish institution or organisation by which it had been payable."
  - (b) by omitting from Section 14 words "so responsible" and by inserting in lieu thereof the words "responsible for the payment of the stipend of that clergyman".
