THE CORAKI LAND MORTGAGE GRDINANCE 1935 AMENDING ORDINANCE 1938.

WHEREAS by the provisions of the Coreki Land Mortgage Ordinance 1935 the Corporate Trustees of the Diocese of Grafton were empowered to mortgage the lands described in the Schedule therete AND WHIRLAS by reason of circumstances subsequent to the passing of the said Ordinance it has become necessary to obtain a new sub-division of the land mentioned in the aforementioned schedule and it is expedient to amend the said Ordinance AND WHEREAS by an Act of Ferliament passed in the eighth year of the reign of His Majesty King George the Fifth intituled "Church of England Trust Property Act 1917, No 21", it was enacted that during the recess of Synod a Committee, Council or other body of persons appointed for that purpose by Ordinance might in the place of such Synod of the Diocese exercise such of the powers and functions and do and make such of the things referred to in the said Act as should be determined by Ordinance of the Synod of such Diocese AND WHIREAS by an Ordinance of the Synod of the Diocess of Grafton passed in the year 1934 the Bishop-in-Council was appointed for the purpose of exercising and might accordingly during the recess of such /of Synod/the said Diocese exercise in the place of such Synod/or all of the /any powers and functions and do and make any or all of the things referred to in such Act, Section 26 thereof as may be done by the Synod NOW the Bishop-in-Council of the Synod of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the said Act and Ordinance and in pursuance of the powers vested in the said Synod by the Constitutions for the management and good government of the Church of England within the State of New South Wales and by the "Church of England Trust Property Act 1917" or otherwise in the name and in the place of such Synod ordains, directs and rules as follows:-

1. The Coraki Lend Morogage Ordinance 1935 shall be and hereby is amended by the emission in the Schedule thereto of all the words after the word "containing" in the first line and inserting in lieu thereof the following words:

"by admeasurement one acre and one quarter perch more or less situated in the County of Richmond Parish of West Coraki Village of Coraki being the whole of Lot Two of the New Sub-division of the hitherto existing Sub-division of Section No 31 COMMENCING at the south east corner of allotment 1 of the hitherto existing Sub-division bounded thence on the east by the western side of Coraki Street 170 6/10 links north thence on the north by a line at right angles to Coraki Street 599 7/10 links west through allotments 1, 2 and 3 of the hitherto existing Sub-division to the western boundary of allotment 3 thence on the west by the western boundary of that allotment 126 7/10 links south to its junction with Donaldson Street thence south east by the south western boundary of that allotment to a point 103 9/10 links from the aforesaid junction thence by the southern boundaries of allotments. 3, 2 and 1 of the hitherto existing Sub-division 505 3/10 links east to the point of commencement.

2. This Ordinance may be known and cited as the Coraki Land Mortgage Ordinance 1935 Amending Ordinance 1938.
