# PREAMBLE

Whereas the validity of the Coffs Harbour Rectory Land Mortage Ordinance 1937 (hereinafter designated the said Ordinance) a copy of which is contained in the Schedule hereto has been challenged on the procamble of lack of proof of certain allegations contained in the schedule thereto. And Whereas the allegations so challenged have been the validity of the said Ordinance be removed. - 2. The said Ordinance is hereby revoked but such revocation shall not be held to invalidate any act matter or thing done or commenced thereunder notwithstanding that the said Ordinance may have contained some defect at the time.
- 3. The proceedings taken in conformity with Sections 34 to 38 of the Church Trust Property Ordinance 1934 for the initiation of the said Ordinance now revoked shall be continued and accepted as the proceedings in respect to the Ordinance to be re-enacted.
- 4. The Coffs Harbour Rectory Land Mortage Ordinance 1937 a copy of which is contained in the Schedule annexed hereto is herely renacted and the Short Title thereto amended to read "The Coffs Harbour Rectory Land Mortage Ordinance 1939"
- This Ordinance may be cited as the Coffs Harbour Rectory Land Morrage Ordinance 1937 Revocation and Re-enacting Ordinance 1939.

## DECLARATION OF OPINION

1. It is expedient and desirable to mortgage the lands described in the Schedule hereto for a sum of three hundred and twenty five pounds.

2. It shall be lawful under and by notice of the powers conferred by the Church of England Trust Property Act 1917 from time to time to mortgage the lands described in the Schedule hereto for a sum or sums not exceeding three hundred and twenty five pounds.

PROVIDED that after the expiration of five years from the date in the first instance of the mortgaging no renewal of any such mortgage or no fresh mortgage shall be valid for a larger sum than two hundred pounds and thereafter no such renewal and no fresh mortgage shall be valid unless the sum thereby secured is less than the sum of two hundred pounds after deducting therefrom the sum of at least twenty five pounds per annum for each further year that shall have elapsed from the passing of this ordinance.

3. The Corporate Trustees of the Diocese of Grafton shall in its own name and as its own act and deed execute and do all necessary mortgages or other securities acts and things for giving full and complete effect to the provisions of this Ordinance according to its true intent and meaning.

4. The moneys advanced on any such mortgage shall be paid to the Corporate Trustees of the Diocese of Gration whose receipt shall be an effectual discharge and no mortgagee shall be concerned to see the application of the money so advanced.

The Corporate Trustees of the Diocese of Grafton shall apply the money so advanced as follows:— In repaying to the Bank of New South Wales the moneys due under the mortgage and agreement referred to in the Preamble hereto.

### SHORT TITLE

5. This Ordinance may be cited as "The Coffs Harbour Rectory Land Mortgage Ordinance 1937"
