

TYNDALE LANDS VESTING ORDINANCE 1947.

WHEREAS the lands situated in the Parish of Tyndale and described in the schedule hereto were by an indenture dated the eighteenth day of October 1881 and registered number 619 Book 232 vested in John Joseph Fough, Charles Farlow and Thomas Alexander Powell and their heirs upon trust to erect build maintain and keep thereon a church for the use and benefit of all persons professing the faith of the Church of England AND WHEREAS the said three trustees are all now deceased and the land has become vested in some one or more of their heirs or personal representatives or in the personal representatives of the survivor of them AND WHEREAS by section 19 of the Church of England Trust Property Act 1917 it was declared that any Church Trust property which might at any time belong to or be vested in any trustee or trustees should upon the consent of the Synod of the Diocese for which such property was held given by an ordinance of such Synod by virtue of such consent and without other assurance in the law become vested in the Corporate Trustees of such Diocese AND WHEREAS section 40 of the said Act provided that during the recess of the Synod of a Diocese such committee council or other body of persons as should be constituted for the purpose by ordinance of such Synod might exercise such of the powers and functions and do and make such of the things referred to in that Act as such Synod should from time to time by Ordinance direct AND WHEREAS by section 42 of the Bishop in Council Ordinance 1934 the Synod of the Diocese of Grafton appointed the Bishop in Council of the said Diocese to exercise within the said Diocese and during recess of the said Synod certain powers given to the said Synod by the said Act including the powers conferred by Section 19 thereof AND WHEREAS the said Synod is now in recess NOW the Bishop in Council of the Diocese of Grafton in pursuance of the powers conferred upon it in that behalf by the said section 19 of the said Act and by the said ordinance and of all other powers it thereunto in anywise enabling hereby ordains directs and rules.

VESTING.

1. Consent is hereby given to the lands described in the schedule hereto being vested by virtue of such consent and without further assurance in the law in the Corporate Trustees of the Diocese of Grafton.



SCHEDULE.

ALL THAT piece or parcel of land containing by measurement one rood two perches be the same more or less situated in the Parish of Tyndale County of Clarence being a subdivision of portion number six commencing at the intersection of the south boundary of the surveyed line of road with the western boundary of portion number six Parish of Tyndale County of Clarence bearing South about fifty links from the north west corner of that portion and bearing north seventy nine degrees thirty four minutes east sixteen links from the nearest angle peg of the aforesaid road and bounded thence on the north west by part of the south east boundary of the aforesaid road bearing north seventy nine degrees thirty four minutes east two hundred links thence on the north east by a line bearing south nine degrees forty minutes east one hundred and twenty five links thence on the south east by a line bearing south seventy nine degrees thirty four minutes west two hundred and twenty three links to the west boundary of portion six aforesaid thence on the west by part of the west boundary of portion number six aforesaid bearing north one hundred and twenty seven links to the point of commencement.

DEDICATION.

1. The said Corporate Trustees are hereby empowered and directed to dedicate to the use of the public as part of the adjoining highway the northernmost part of allotment two of section eighteen of the said land to a depth of ten feet with full power to the said Corporate Trustees to make and do all such transfers deeds applications and documents which may be necessary to give effect to such dedication.

SUBDIVISION.

2. The said Churchwardens and Parochial Council of the Parish of Casino are hereby empowered by their secretary or clerk to make application to the Municipal Council of the Town of Casino for leave to subdivide the remainder of the said allotment two so as to form thereout a new lot hereinafter called lot A having full frontage to the land so dedicated by a depth of one hundred and thirty two feet and bounded on the south by a line parallel with the southern boundary of the said allotment.

3. The said Churchwardens and Parochial Council are empowered in like manner to subdivide allotment twenty of section eighteen so as to form a new lot (hereinafter called lot B) bounded on the north by the northern boundary of the said allotment and on the south by a line parallel therewith and having a frontage of seventy three feet to West Street, the remainder of the said allotment being hereinafter referred to as lot C.

REMOVAL AND ERECTION OF BUILDINGS.

4. The said Churchwardens and Parochial Council are hereby empowered to cause to be removed from the said lot C the existing Rectory and to dispose of the materials therefrom as they shall think fit, and to cause to be erected on each of the said lots A and B a cottage either or both of which may be let to produce income.

5. The said Churchwardens and Parochial Council are hereby empowered at such time as shall be practicable and convenient to cause a new Rectory to be built on the said lot C.

6. This ordinance may be cited for all purposes as the "Casino Lands Subdivision and Dedication Ordinance 1947"
