WHEREAS the lands situated in the Town of Kempsey and described in the schedule thereto were by an indenture dated First day of August One thousand eight hundred and sixty eight and registered number 674 Book 109 yested in Frederick Richard Kemp, Thomas Bradbery and William Thomas Dangar and their heirs upon trust for and to permit the same to be used for educational purposes in connection with the Church of England AND WHEREAS the said three trustees are all now deceased and the land has become vested in some one or more of their heirs or personal representatives or in the personal representatives of the survivor of them AND WHEREAS by section 19 of the Church of England Trust Property Act 1917 it was declared that any Church Trust property which might at any time belong to or be vested in any trustee or trustees should upon the consent of the Synod of the Diocese for which such property was held given by an ordinance of such Synod by virtue of such consent and without other assurance in the law become vested in the Corporate Trustees of such Diocese AND WHEREAS section 40 of the said Act provided that during the recess of the Synod of a Diocese such committee council or other body of persons as should be constituted. for the purpose by ordinance of such Synod might exercise such of the powers and functions and do and make such of the things referred to in that Act as such Synod should from time to time by Ordinance direct AND WHEREAS by section 42 of the Church Trust Property Ordinance 1934 the Synod of the Diocese of Grafton appointed the Bishop in Council of the said Diocese to exercise within the said Diocese and during recess of the said Synod certain powers given to the said Synod by the said Act including the powers conferred by Section 19 thereof AND WHEREAS the said Synod is now in recess NOW the Bishop in Council of the Diocese of Grafton in pursuance of the powers conferred upon it in that behalf by the said section 19 of the said Act and by the said ordinance and of all other powers it thereunto in anywise enabling hereby ordains directs and rules.

l. Consent is hereby given to the lands described in the schedule hereto being vested by virtue of such consent and without further assurance in the law in the Corporate Trustees of the Diocese of Grafton.

## SHORT TITLE.

2. This ordinance may be cited for all purposes as the "East Kempsey Lands Vesting Ordinance 1963".

## SCHEDULE.

ALL THAT allotment or parcel of land situate lying and being in the Town of East Kempsey County of Macquarie and Colony of New South Wales aforesaid containing by estimation two roods be the same a little more or less bounded by Innes Street and being allotment One hundred and fifty eight as delineated or described in the Map or plan of the Town of Kempsey.
