

DIOCESE OF GRAFTON.

HERON'S CREEK TRANSFER ORDINANCE.

1939.

PREAMBLE.

WHEREAS it is expedient to alter the boundaries of the Diocese by the transfer to the Diocese of Newcastle of the territory known as Heron's Creek be it ordained by the Bishop Clergy and Laity in Synod assembled as follows:-

SHORT TITLE.

1. This ordinance may be cited as the Heron's Creek Transfer Ordinance 1939.

SURRENDER OF TERRITORY.

2. Part of the territory of the Diocese of Grafton known as Heron's Creek, the boundaries of which are set out in the first schedule hereto is hereby surrendered to the Diocese of Newcastle.

CONDITIONS.

3. The Condition of such surrender is that the Diocese of Newcastle pay and discharge all existing debts and liabilities in respect of all church property within the territory so surrendered.

ALTERATION OF BOUNDARIES.

4. In pursuance of Section 45 subsection 4 of the Church of England Trust Property Act 1917 as amended by the Church of England Trust Property (Amendment) Act (No.2) 1923 consent is hereby given to the alteration of the boundaries of the Diocese accordingly.

ALLOCATION OF PROPERTY.

5. In pursuance of Section 22 of the Church of England Trust Property Act 1917 the church property within the territory hereby surrendered and described in the second schedule hereto is hereby allocated for the Diocese of Newcastle as from the date of the passing of this ordinance.

THE FIRST SCHEDULE.

All that portion of the County of Macquarie within the following boundaries:- Commencing on the sea coast where Cathie Creek empties, bounded thence by Cathie Creek and Ten Mile Creek upwards to the crossing of the Main Coast road within Portion 9 Parish of Burrawan thence by the boundaries of that portion northerly and westerly and northerly to the south eastern corner of Cawarra State Forest Number 59 Thence by the southern boundary of that State Forest and its prolongation westerly to the north-coast railway Thence by that railway northerly to the southern boundary of portion three of the Parish of Koree Thence by the boundaries of that portion westerly and northerly to the south eastern corner of portion 4 Thence by the boundaries of that portion westerly and northerly to the top of Broken Bago Range Thence by the top of that range generally south westerly to its intersection with the southern boundary of the Diocese Thence by the southern boundary of the Diocese easterly to the sea Thence by the seashore northerly to the point of commencement.

THE SECOND SCHEDULE.

All that piece or parcel of land situated in the Shire of Hastings Parish of Ralfe and County of Port Macquarie being part of Portion Thirty nine comprised in Certificate of Title registered Volume 3228 Folio 147.

I hereby certify that the ordinance as printed is in accordance with the Ordinance as passed.
