## Appendix No. 20.

DETERMINATION II.: GENERAL SYNOD, SESSION 1937.
(Made 22nd October, 1937.)

DETERMINATION TO FURTHER AMEND DETERMINATION VII., GENERAL SYNOD, SESSION 1905.

Whereas it is expedient to further amend Determination VII., General Synod 1905, be it enacted by the Archbishops Bishops Clergy and Laity in General Synod as follows:—

1. At the end of Rule 2 there shall be added the following words: "For the purpose of this and the succeeding Rule a Coadjutor Bishop shall be deemed to be and have the status of a licensed Clergyman."

2. Immediately after Rule 13 of the said Determination there shall be inserted the following Rules:—

13a. Any Diocese accepting this Determination may on acceptance or at any future time elect to do so on acceptance or at any future time elect to do so on the basis of securing to all or any of its subscribers increased benefits not exceeding double the present increased benefits provided at the discretion of the Board in benefits provided at the discretion of the Board in consultation with its Actuary. Such increased benefits may be secured on the following conditions:

fits may be secured on the following conditions:

(a) Subject to satisfactory evidence of the subscriber's health;

(b) If the subscriber is unmarried or has a wife not more than three years younger than he and has not more than two children under the age of

sixteen years upon payment of an annual contribution to be calculated at increased rates to those set forth in the Schedules to the Determination on the basis of the then age of the subscriber;

(c) Under any other circumstances upon payment of an annual contribution to be fixed by the Board in consultation with its Actuary.

13b. Any subscriber in a diocese which has not accepted the Determination may subject to the approval of the Board secure increased benefits upon like conditions.

13c. Upon the superannuation of any subscriber securing increased benefits his allowance shall not exceed £300 per annum and shall be subject to reduction as proyided in Rule 20.

3. 26b. After the word "Fund" in the second line Rule 26 (b) shall be added the following words "Ordained Deaconesses and."

4. In Rule 28 the words, "A duly audited statement of receipts and expenditure on account of the said Fund together with a statement of assets and liabilities," are hereby repealed and the following words substituted therefornamely: "A duly audited statement of income and expenditure on account of the said Fund together with a balance sheet showing a summery of liabilities and assets."
