THE DIOCESAN DEVELOPMENT FUND (AMENDMENT) ORDINANCE 1957

AN ORDINANCE

To amend the Diocesan Development Fund (Amendment) Ordinance 1954 WHEREAS it has become necessary and desirable to borrow certain additional moneys towards the completion of a building at Grafton for a Community Centre for Youth gatherings, conferences and retreats and provision of the furnishings and equipment therein AND WHEREAS by Act of Parliament passed in the eighth year of the reign of His Majesty King George the Fifth entitled "Church of England Trust Property Act 1917 No. 21" it was enacted that during the recess of the Synod, a Committee, Council or other body of persons appointed for that purpose by Ordinance might, in place of the Synod of the Diocese exercise such of the powers and functions and do and make such of the things referred to in the said Act as should be determined by Ordinance of the Synod of such Diocese AND WHEREAS by Ordinance of the Synod of the Diocese of Grafton passed in the year one thousand nine hundred and thirty-four the Bishopin-Council was appointed for the purpose of exercising and might accordingly during the recess of such Synod of the said Diocese exercise in the place of such Synod any or all of the powers and functions and do and make any or all of the things referred to in Sections 26,27 and 32 of the said Act as may be done by the Synod AND WHEREAS by the said Diocesan Development Fund Ordinance 1949-1950 the Corporate Trustees of the Diocese of Grafton (hereinafter called "the Corporate Trustees") were thereby authorised for such purposes to borrow such additional moneys as the Bishop-in-Council might deem necessary or desirable NOW THEREFORE the Bishopin-Council of the Synod of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the said Synod the said Act and the said Ordinances and in pursuance of the powers vested in the said Synod by the Constitution for the management and good government of the Church of England within the State of New South Wales and by the "Church of England Trust Property Act 1917"

or otherwise in the name and the place of such Synod ordains direct and rules as follows:

SHORT TITLE

- This Ordinance may be cited as the Diocesan Development (a) Fund (Amendment) Ordinance 1957.
- The Diocesan Development Fund Ordinance 1949-1954 as (b) amended by this Ordinance may be cited as the "Diocesan Development Fund Ordinance 1949-1957.

OPINION

2. It has become necessary and desirable for the purposes aforesaid to borrow certain additional moneys.

AMENDMENT

Section 2 of the Diocesan Development Fund (Amendment) 3. Ordinance 1954 is amended by substituting the words and figures "Fourteen thousand pounds (£14,000.0.0)" for " Twelve thousand pounds (£12,000.0.0.)".
