TWEED HEADS LAND SALE ORDINANCE 1966

AN ORDINANCE to provide for the sale of certain lands at Tweed Heads in the Parish of Tweed Heads.

PREALBLE

WHENEAS the lands described in the schedule hereto are vested in the Corporate Trustees of the Diocese of Grafton AND WHEREAS by the Church of England Trust Froperty Act of 1917 and the Church Trust Froperty Ordinance of 1934 the Bishop-in-Council is empowered during a recess of Synod to exercise certain powers of Synod including the powers conferred by Part VI of the said Act AND WHEREAS such recess now exists the Bishop-in-Council in pursuance of such powers and in the name of the Synod archive directs and rules as follows: powers and in the name of the Synod ordains directs and rules as follows:

OPINION

It has become and is expedient, by reason of circumstances subsequent to the creation of the trusts relating to the lands described in the schedule hereto, to sell the same.

POWERS TO SELL

- The Corporate Trustees in whom the said lands are vested are hereby empowered and directed to sell the same by public auction or private dontract and for such sum or sums of money and upon such terms and conditions as may be determined by the Corporate Trustees.
- The Corporate Trustees are hereby authorised to execute and do all necessary deeds conveyances transfers assurances and other instruments acts and things for giving full and complete effect to the provisions of this Ordinance.
- The moneys arising out of such sale shall be paid to the Corporate Trustees and after provision has been made for all costs charges and expenses relating thereto shall be applied by them to such purposes as the Parochial Council of Tweed Seads may nominate subject to the approval of the Bishop-in-Council.

SHORT TITLE

This Ordinance may be cited as the Tweed Seads Land Sale Ordinance 1966.

SCEDULE

ALL THAT piece of land having a frontage of 75 links to Beryl Street Tweed Beads with a depth of 200 links being Lot 7 of Section 2 in Deposited Plan No. 4043 in the Parish of Terranora County of Rous Shire of Tweed whole of that comprised in Certificate of Title Volume 3299 Folio 13.


