# AMENDMENT ORDINANCE 1978

### AN ORDINANCE

TO amend the Long Service Leave Ordinance 1968 (hereinafter referred to as the "Principal Ordinance").

The Bishop, Clergy and Laity of the Diocese of Grafton in Synod assembled decree and enact as follows:-

### SHORT TITLE

- (a) This ordinance may be cited as the "Long Service Leave Ordinance Amendment Ordinance 1978".
  - (b) The Principal Ordinance as amended by this ordinance may be cited as the "Long Service Leave Ordinance 1968-1978".

#### ADOPTION

2. The amendments made to the Long Service Leave Canon 1966-1973 by the Long Service Leave Amendment Canon 1977, which amendments are set out in the schedule hereto, are approved and adopted and each reference in the Principal Ordinance to the Long Service Leave Canon 1966 shall be read and construed as a reference to the Long Service Leave Canon 1966-1977.

## THE SCHEDULE

## No. 2, 1977

### A CANON TO AMEND THE LONG SERVICE

# LEAVE CANON 1966-1973

The general synod prescribes as follows:

- (a) This canon may be cited as "Long Service Leave (Amendment) Canon 1977"
  - (b) The Long Service Leave Canon 1966-1973 is in this canon referred to as "the principal canon".
  - (c) The principal canon as amended by this canon may be cited as "Long Service Leave Canon 1966-1977".

- The principal canon is amended:
  - (a) by substituting for Section 1 (j) the following:
    - "(j) "Service" means service in a full time capacity
      - (i) as a clergyman in any diocese of the Church of England in Australia or in any diocese which was formerly part of the Church of England in Australia,
      - (ii) as a missionary priest, being service which the Board with the approval of the Standing Committee of general synod prescribes either generally or in a particular case to be or to have been missionary service

including any period during such service of annual holiday leave or of furlough and including any period of long service leave under this canon and "serve" and "serving" have corresponding meanings."

- (b) by adding at the end of Subsection 4(a) the following:
  - "(iii) missionary service at any time"
- (c) by inserting in Subsection 4(b) at the end of paragraph (ii) the following: "or where that service is missionary service, in respect of which there has not been paid to the Fund a sum which corresponds to the aggregate of the contributions which would have been payable . in respect of a like period of service in a participating diocese.
