THE NORTH COAST CHILDREN'S HOME LAND MORTGAGE (AMENDMENT) ORDINANCE 1951

An Ordinance

To amend the North Coast Children's Home Land Mortgage Ordinance 1935 by increasing the borrowing powers of the Corporate Trustees of the Diocese of Grafton thereunder

WHEREAS by Act of Parliament passed in the eighth year of the reign of His Majesty King George the Fifth entitled "Church "of England Trust Act 1917 No. 21" it was enacted that during the recess of the Synod a Committee Council or other body of persons appointed for that purpose by Ordinance might in place of the Synod of the Diocese exercise such of the powers and functions and do and make such of the things referred to in the said Act as should be determined by Ordinance of the Synod of such Diocese AND WHEREAS by Ordinance of the Synod of the Diocese of Grafton passed in the year one thousand nine hundred and thirty four the Bishop-in-Council was appointed for the purpose of exercising and might accordingly during the recess of such Synod of the said Diocese exercise in the place of such Synod any or all of the powers and functions and do and make any or all of the things referred to in Sections 26 and 27 of the said Act as may be done by the Synod AND WHEREAS such Synod is now in recess NOW THEREFORE the Bishop-in-Council of the Synod of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the said Act and the said Ordinance and in pursuance of the powers vested in the said Synod by the Constitution for the management and good government of the Church of England within the State of New South Wales and by the "Church of England Trust Property Act 1917" or otherwise in the name and in the place of such Synod ordains directs and rules as follows: --

SHORT TITLE.

1. (a) This Ordinance may be cited as The North Coast Children's Home Land Mortgage (Amendment) Ordinance 1951.

- (b) The North Coast Children's Home Land Mortgage Ordinance 1935 is in this Ordinance referred to as the Principal Ordinance.
- (c) The Principal Ordinance as amended by this Ordinance may be cited as "The North Coast Children's Home Land Mortgage".
 "Ordinance 1935-1951."

AMENDMENT:

2. Section 1 of the Principal Ordinance is hereby amended by substituting the words "Three thousand seven hundred pounds "for the words "Two thousand five hundred pounds".
