PORT MACQUARIE GLEBE (FURTHER AMENDMENT) ORDINANCE 1950. AN ORDINANCE.

For further amend the Port Macquerie Glebe Ordinance 1948-1950 in connection with the disposal of certain unsald allotments within the subdivision of the said lands WIEREAS by Act of Parliament passed in the eighth year of the reign of His Majesty King George 10 Fifth entitled "Church of England Trust Property Act 1917 No. 21." it was enacted that during the recess of the Synod a Committee Council or other body of persons appoir for that purpose by Ordinance might, in place of the Synod of the Diocese exercise sucl of the powers and functions and do and make such of the things referred to in the said Act as should be determined by Ordinance of the Synod of such Diocese AND WHEREAS by Ordinarce of the Synod of the Diocese of Grafton passed in the year one thousand nine hundred and thirty four the Bishop-in-Council was appointed for the purpose of exercis and might accordingly during the recess of such Synod of the said Diocese exercise in place of such Synod any or all of the powers and functions and do and make any or all the things referred to in Sections 26,27 and 32 of the said Act as may be done by the Synod NOW THEREFORE the Bishop-in-Council of the Synod of the Dioceso of Grafton in pursuance of the powers in that behalf conferred upon it by the Synod by the said Act the said Ordinance and in pursuance of the powers vested in the said Synod by the constitution for the management and good government of the Church of England within t State of New South Wales and by the "Church of England Trust Property Act 1917" or otherwise in the name and place of such Synod ordains directs and rules as follows:-

Short Titlo

- 1. (a) This Ordinance may be cited as the Port Macquarie Globe (Further Amendment) Ordinance 1950.
 - (b) The Port Macquarie Glebe Ordinance 1948-1950 is in this Ordinance referred to as the Principal Ordinance.
 - (c) The Principal Ordinance as amended by this Ordinance may be cited as "Port Macquarie Globe Ordinance 1948-1950".

AMENDMENT.

- 2. Section 5 of the Port Macquaric Globe (Amendment) Ordinance 1950 is amended by omitting the numbers "55. 56. 57. 85. 86. 87."
 - 3. Allottments 55,56,57, 8, 86 and 87 in the said subdivision shall become be the absolute propert of the said Parish and shall be so retained an enjoyed for church purposes and use or for such other purposes as the C Trustees may from time a time permit, PROVIDED ALMAYS that in respect lands so utilised the Frachial Council shall observe and impose such restrictions upon the reparation, construction and use of the lands are buildings erected there as the said Trustees may from time to time di
