## THE GRAFTON BISHOPRIC ENDOWMENT AND ADMINISTRATION (AMENDMENT) ORDINANCE 1950. AM ORDINANCE.

To amond the Grafton Bishopric Endowment 1933 and the Grafton Bishopric and Administration Ordinance 1936 WHEREAS by Act of Parliament passed in the eighth year of the reign of His Majesty King George the Fifth entitled "Church of England Trust Property Act 1917 No. 21" it was enacted that during the recess of the Synod, a Committee, Council or other body of persons appointed for that purpose by Ordinance might, in place of the Syned of the Dicese exercise such of the powers and functions and do and make such of the things referred to in the said Act as should be determined by Ordinance of the Synod of such Diocese AND WHEREAS by Ordinance of the Synod of the Dicceso of Grafton passed in the year one thousand nine hundred and thirty-four the Bishop-in-Council was appointed for the purpose of exercising and might accordingly during the recess of such Synod of the said Diocese exercise in the place of such Syned any or all of the powers and functions and do and make any or all of the things referred to in Sections 26, 27 and 32 of the said Act as may be done by the Synod AND WHEREAS by the said Ordinance it shall be the duty of the Bishop-in-Council to discharge all duties specifically assigned to it from time to time by the said Synod under resolution AND WHEREAS by a resolution of Synod passod on the twentioth day of Septembor 1950 the Bishop-in-Council was authorised and requested to amend the existing Ordinance in terms of this enactment NOW THEREFORE the Eishop-in-Council of the Synod of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the said Synod the said Act and the said Ordinance and in pursuance of the powers vested in the said Synod by the Constitution for the management and good government of the Church of England within the State of Now South Wales and the "Church of England Trust Property Act 1917" or otherwise in the name and in the place of such Synod ordains directs and rules as follows:-

## SHORT TITLE.

1. This Ordinance may be cited as "The Grafton Bishopric Endowment and Administration (Amendment) Ordinance 1950"

## AMENDMENT.

- 2. Section 4 of the Grafton Bishopric Endowment Ordinance 1933 is amended by substituting the words "One thousand" for the words "eight hundred".
- 3. Section 5 of the same Ordinance is amended by substituting the words "One thousand" for the words "eight hundred."
- 4. Section 15 of the Grafton Bishopric and Administration Ordinance 1936 is amended by substituting the words "One thousand" for the words "Eight hundred"
- 5. This Ordinance shall be deemed to have come into force and become fully offective as from the first day of October 1950.
