CATHEDRAL (ALENDAENT) ORDINANCE 1950.

AN ORDINANCE.

To amend the Cathedral Ordinance 1937-49 WEREAS by an Ordinance of the Synod of the Diocese of Graften passed in the year One thousand nine hundred and thirty-four it shall be the duty of the Bishop-in-Council to discharge all duties specifically assigned to it from time to time by the said Synod under resolution AND WEREAS by a resolution of Synod passed on the twentieth day of September 1950 the Bishop-in-Council was authorised and requested to amend the existing ordinance in terms of this enactment NOW THEREFORE the Bishop-in-Council of the Synod of the Diocese of Graften in pursuance of the powers in that behalf conferred upon it by the said Synod and the said Ordinance and in pursuance of the powers vested in the said Synod by the Gonstitution for the management and good government of the Church of England within the State of New South Wales in the name and in the place of such Synod ordeins and directs and rules as follows:-

CATIEDRAL (A THIDLENT) ORDINANCE 1950.

SHORT TITLE.

(1) This ordinance may be cited as "Cathedral (Amendment) Ordinance 1950".
 (2) The Cathedral Ordinance 1937-1949 is in this Ordinance referred to as the Principal Ordinance.

(3) The Principal Ordinance as amended by this Ordinance may be cited as "The Cathedral Ordinance 1937-1950."

 Section 5 (c) of the Principal Ordinance is amended by substituting the word "appoint" for the words "proceed to instal."

3. Soction 20 of the Principal Ordinanco is amended by substituting the word "hereof for the word "heroto."

4. Section 36 of the Principal Ordinance is amended by substituting the words "occurring in the membership of the Council from any cause whatever shall effect the validity of its proceedings " for the words "in the members chall from any cause whatever affect the validity of the proceedings of the Council Ordinance is amended by substituting the words."

Section 41 of the Principal Ordinance is amended by substituting the words "Bishop-in-Council" for the word "Synod" and the word "meeting" for the word "session". After the word "meeting" add "Bishop-in-Council will then have the said account laid on

Section 46(1)(g) is omitted and the following subsection inserted in lieu thereof;(g) During the Dean's absence on leave or during any period whom he shall cease to
appointed the Bishop or his Deputy with the Chapter shall have and may exercise
the powers and duties of the Dean under this Section.

7. Section 50 of the Principal Ordinance is obligate.

- 9. Section 3 of the Diocesan Missionary Ordinance 1932 No 4 is amended by inserting after the word "Chairman" the words "The Dean of Chairman"
- 10. Section 2 of the Diocesan Education Ordinance 1933-1948 is amended by inserting after the words "The Bishop" the words "The Doan of Committee,"
