PORT MACQUARIE GLUBE LANDS VESTING ORDINANCE.

WHEREAS by Crown Grant dated the ninth day of May 1842 under the hand of his Excellency Sir George Gipps then Governor of the Colony (now State) of New South Wales Her most Gracious Majesty Queen Victoria did thereby grant unto the Lord Bishop of Australia the Reverend John Cross Archibald Clunes Innes, William Nairn Gray and William Henry Geary their Heirs and Assigns upon trust for the appropriation thereof as the Glebe annexed to the Church of the United Church of England and Ireland as by law established erected at Port Macquarie and knows as St Thomas's, all those pieces or parcels of land described in the schedule hereto. AND WHEREAS by them Grafton Diocese Ordinance 1910 passed by the Synod of the Diocese of Grafton and Armidale in that year it was enacted that from and after the confirmation and election of a duly qualified person in Episcopal Orders to be Bishop of Grafton all that portion of the State of New South Wales described and defined in the schedule of the said Ordinance should become and be a separate Diocese to be called the Diccese of Grafton and that when the Bishop of Grafton should have been installed he should exercise within the limits of the Diocese all the powers rights and authorities which a Bishop of the Church of England in New South Wales might lawfully exercise and should be for all purposes the successor of the Bishop of Grafton and Armidale in such Diocese AND WHEREAS by the schedule of the said Ordinance the limits of the Diocese of Grafton are described as follows that is to say COMMENCING at Tweed Heads thence along the Queensland border to the western boundary of the County of Rous thence along the western boundary of the said County to its junction with the County Richmond thence along the western boundary of the County Richmond to Deadman Creek along that Creek in a westerly direction to Duldigan Creek to the boundary nof the Parish of Alice thence in a south westerly direction to the junction of the Parish of Alice with that of Hamilton along the southern boundary of Hamilton to its junction with that of Hong Kong thence along the western boundary of Hamiltion to its junction with the Timbarra River thence along the said River in a south westerly direction to its junction with the boundary of the County Drake thence along the western boundary of the said County to its junction with the Mitchell River thence along the said river to Newton Boyd

thence along the western boundary of the County Grasham to its junction with the County Fitzroy thence along the western boundary of the said County to the northern, of the Parish of Marengo thence along the northern boundaries of the Parishes of Marengo and Brown thence southward along the western boundary of the Parishes of Brown and Falls to the Parish of Doughboy thence westward to the Doughboy Mountains along the said Mountains to the Parish of Serpentine thence along the western boundaries of the Parishes of Serpentine and Gunnawarra thence along the southern boundary of Gunnawarra to the Western boundary County Dudley thence along the western boundary of the said County to its junction with County Macquarie thence along the western boundary of the said County Macquarie to the northern boundary of the County of Hawes thence glong the said boundary of the County of Hawes to its junction with the northern boundary of the Diocese of Newcastle thence along the said boundary of the Diocese of Newcastle to the South Pacific Ocean thence northwards to Tweed Heads AND WHEREAS the before mentioned lands are situated within the boundaries of the Diocese of Grafton as before described AND WHEREAS it is desirable that the same should become vested in the Corporate Trustees of the Diocese of Grafton BE IT THEREFORE ENACTED by the Council of the Diocese of Grafton under and by virtue of the Delegation of Powers Ordinance 1918 and in exercise of the powers conferred by section 19 of the Church of England Trust Property Act 1917 as follows.

- CONSENT is hereby given to the lands described in the schedule hereto being by virtue of such consent and without further assurance in the law vested in the Corporate Trustees of the Diccese of Grafton.
- THIS Ordinance may be cited as the Port Macquarie Glebe Lands vesting Ordinance 1920.

THE SCHEDULE.

ALL THOSE pieces of land in the said State of New South Wales containing by admeasurement forty acres be the same more or less situated in the County of Macquarie and Parish of Macquarie First portion containing two roods situated in the County and Parish aforesaid and town of Macquarie in front of the Church allotment number one of section number seven commencing at the

Street two chains on the southward by a line at right angles to that street two chains fifty links on the eastward by a line at right angles to that street two chains fifty links on the eastward by a line at right angles to the last line two chains to William Street and on the northward by that street two chains fifty links to the corner of Hay and William Streets. Second portion containing thirty nine corresponded at two roods situated in the County and Parish aforesaid at the junction of Koolumbung and Wright's Creeks bounded on the north by Wright's Creek eighteen chains (commencing at the junction of the two creeks) On the east by a, line south fourteen chains eighty finks on the south by a line west twenty seven chains to the Koolumbung Creek and on the west by that Creek to the junction of the Creeks (advertised as number sixteen in the Government Notice dated eighth of February One thousand eight hundred and forty two)
