

**THE PAROCHIAL ORDINANCE, 1918, AMENDING
ORDINANCE, 1932, NO. 2**

AN ORDINANCE to repeal a certain Section of an Ordinance relating to the Corporate Trust and to insert a new section in lieu thereof.

PREAMBLE.

WHEREAS by an Act of Parliament passed in the eighth year of the reign of His Majesty King George the Fifth intituled

“The Church of England Trust Property Act, 1917,” or Section nine of the said Act power is given to the Synod of a Diocese to vary from time to time by Ordinance the provisions of sections seven and eight of the Act in so far as the same relate to such Diocese AND WHEREAS the Synod of the Diocese of Grafton in pursuance of the said power and in pursuance of the powers vested in the same Synod by the Constitutions for the management and good government of the Church of England within the State of New South Wales did, by an Ordinance, intituled “The Parochial Ordinance, 1918,” in Section seven of Part IVA thereto determine that the affixing of the Common Seal of the Trust shall be verified by the signature of not less than three of the Corporate Trustees and the signature of the Secretary AND WHEREAS owing to possible undue delay in the affixing of the Common Seal which might be caused through the unavoidable absence of the Secretary it is expedient to amend the said Ordinance the Synod of the Diocese of Grafton in further pursuance of the powers hereinbefore recited ordains, directs and rules as follows:—

REPEAL.

1. Section 7, Part IVA of the Parochial Ordinance, 1918, is hereby repealed, except as to any operation already effected by or Act done thereunder or as to any right title, obligation or liability already acquired or accrued under the said section and the following new section shall take the place of the said repealed section.

7. COMMON SEAL.

2. The affixing of the Common Seal of the Corporate Trust shall be verified by the signature of not less than three of the Corporate Trustees and any deed or instrument so sealed shall bear on the face thereof a declaration in or to the effect of Form 1 hereunder.

FORM 1.

The Common Seal of the Corporate Trustees of the Diocese of Grafton was hereto affixed pursuant to a resolution passed at a duly constituted meeting of the said trustees held on the day of 19..... in the presence of
