

✓ THE CORPORATE TRUSTEES OF THE DIOCESE OF
GRAFTON AND THE TRUSTEES OF CHURCH PROPERTY
FOR THE DIOCESE OF NEWCASTLE VESTING
ORDINANCE, 1933

SHORT TITLE.

4. This Ordinance may be cited as the "Corporate Trustees of the Diocese of Grafton and the Trustees of Church Property for the Diocese of Newcastle Vesting Ordinance, 1933."

THE SCHEDULE REFERRED TO.

AN ORDINANCE vesting the land described in the Schedule hereto in the Trustees of Church Property for the Diocese of Newcastle and directing the said Trust not to enquire into or take any action in respect of the past administration of the trusts relating thereto.

PREAMBLE.

WHEREAS by Crown Grant bearing date the 5th day of September, 1905, volume 1637, folio 8, the Corporate Trustees of the Diocese of Grafton are the registered proprietors of such land, particulars of which are described in the Schedule hereto.

And WHEREAS such land is in the Diocese of Newcastle and has been used in connection with such Diocese and inserting the title in the name of the Corporate Trustees of the Diocese of Grafton was a mistake. AND WHEREAS it is expedient to correct such mistake and for that purpose it is proposed to vest the said land in the Trustees of Church Property for the Diocese of Newcastle, to which the said land properly belongs. NOW, THEREFORE, the Council of the Diocese of Grafton in pursuance of the powers in that behalf conferred upon it by the "Church of England Trust Property Act, 1917," and the Ordinance of Synod passed in the year One thousand nine hundred and eighteen appointing the Council of the Diocese of Grafton for the purposes of exercising during the recess of Synod the powers and functions in the said Ordinance referred to and in pursuance of the powers vested in the said Synod by the constitutions for the management and good government of the Church of England within the State of New South Wales or otherwise in the name and place of such Synod ordains, declares and rules as follows:—

1. The land in the Schedule hereto (hereinafter designated the said land) shall be and is hereby vested in the Trustees of Church Property for the Diocese of Newcastle by virtue of this Ordinance.
2. That by virtue of this Ordinance the Corporate Trustees of the Diocese of Grafton be and they are hereby empowered to transfer the said land to the Trustees of Church Property for the Diocese of Newcastle for the use, benefit or purposes of the Church of England in the Diocese of Newcastle in the place of the Diocese of Grafton.
3. That the Trustees of Church Property for the Diocese of Newcastle are hereby relieved from the obligation, if any, of enquiring into or taking any action in respect of the past administration of the trusts relating to the said land.

ALL THAT piece or parcel of land containing by admeasure-ment 2 roods situated in the County of Macquarie, Parish of Walibree, village of Comboyne, State of New South Wales, being the whole of the land contained in Crown Grant dated the fifth day of September, One thousand nine hundred and five, volume 1637, folio 8.
