AN ORDINANCE

To incorporate amendments in Amended Ordinances.

The Bishop, Clergy and the Laity of the Diocese of Grafton in Synod assembled declare ordain and enact as follows:-

- 1. When any Ordinace has before or after the passing of this Ordinance been amended by :-
 - (a) The repeal or omission of certain words or figures.
- (b) The substitution of certain words or figures in lieu of any repealed or omitted words or figures.
 - (c) The insertion of certain words or figures.

Then in any reprint of the Ordinances it shall be printed as so amended.

- 2. That a copy of every such amending Ordinance be sent to the Secretary of each Parochial Council.
- 3. In every reprint of an Ordinance so amended a Schedule shall be made reciting the short titles of the various ordinances by which each amendment has been made.
- 4. In this Ordinance "words" include, part, division, heading, section, sub-section, paragraph and schedule.
- 5. This Ordinance may be cited as the "Amendments Incorporation Ordinance 1931."
