SPECIAL TRIBUNAL (LIMITATION PERIOD) CANON 2017 ADOPTING ORDINANCE 2018 Ordinance No. 10 of 2018

The Special Tribunal (Limitation Period) Canon 2017 was passed by the Seventeenth Session of General Synod to amend the Special Tribunal Canon 2007 to remove a time limitation for the consideration of certain offences.

PREAMBLE

Whereas the Special Tribunal (Limitation Period) Canon 2017 as set out in the Schedule hereto was passed by the Seventeenth Session of the General Synod; and

Whereas the Seventeenth Session of the General Synod resolved by sufficient majority in each house that the Bill for the Special Tribunal (Limitation Period) Canon 2017 not be subject to the Special Bill provisions of section 28 of the Constitution of the Anglican Church of Australia; and

Whereas the Special Tribunal Canon 2007 and the Special Tribunal Canon 2007 Amendment Canon 2014 have effect in the Diocese of Grafton; and

Whereas it is desirable that the Special Tribunal (Limitation Period) Canon 2017 of the General Synod of Anglican Church of Australia should be adopted by the Diocese of Grafton;

Therefore the Administrator, Clergy and Laity of the Diocese of Grafton, assembled as the Synod, decree and enact as follows:

ADOPTION BY THE SYNOD OF GRAFTON

 The Diocese of Grafton adopts the Special Tribunal (Limitation Period) Canon 2017 which was Canon 12, 2017 of the Seventeenth Session of the General Synod of the Anglican Church of Australia and set out in the Schedule hereto and consequently the amended Special Tribunal Canon 2007 becomes an Ordinance of the Diocese of Grafton.

COMMENCEMENT

2. This Ordinance shall come into effect upon receiving the assent of the Administrator.

SHORT TITLE

3. This Ordinance may be cited as Special Tribunal (Limitation Period) Canon 2017 Adopting Ordinance 2018.
