THE LISMORE PARISH CENTRE PRE SCHOOL CONSTITUTION ORDINANCE 1989 AMENDING ORDINANCE 2019

Ordinance No. 2 of 2019

An ordinance to amend the Constitution of the Lismore Parish Centre Pre School with regards to the role of the Bishop.

PREAMBLE

Whereas the Constitution of the Lismore Parish Centre Pre School is contained in the Schedule of The Lismore Parish Centre Pre School Constitution Ordinance 1989 Amending Ordinance 2014: and

Whereas it is desirable to have the Constitution amended to clarify the role of the Bishop of Grafton in relation to the Pre School:

Therefore, the Bishop-in-Council in pursuance of powers provided in clause 48.2 of the Diocesan Governance Ordinance 2008 hereby decrees and enacts as follows:

AMENDMENTS

Role of the Bishop

- 1. Amend clause 2 of the Constitution such that "President means the Bishop" is deleted.
- 2. Amend clause 6.2 of the Constitution such that 6.2.1 a) is deleted and subsequent subclauses are renumbered.
- Amend sub-clause 6.6.2 of the Constitution replacing "President" with "Bishop".
- 4. Amend sub-clause 6.6.3 of the Constitution by replacing the existing sub-clause with "At least 7 days' written notice must be given to the Bishop and to each Member specifying the date, time and place of meeting and the business to be transacted."
- 5. Amend sub-clause 6.6.4 of the Constitution by replacing the existing sub-clause with "The Bishop, at his or her discretion, may attend meetings of the Council and, if present, may assume the chair at meetings of the Management Committee."
- 6. Amend sub-clause 6.6.5 of the Constitution by replacing "The person presiding at the meeting of Management Committee" with "Subject to clause 6.6.12, the person chairing a meeting of the Management Committee".
- 7. Insert a new sub-clause 6.6.12 in the Constitution with the words "The Bishop will not have a right to vote at a meeting of the Management Committee regardless of the capacity in which the Bishop attends the meeting."

Amendment History

8. Replace clause 15 Amendment to the Constitution with the following words and subclauses:

***15. Amendment to the Constitution**

- 15.1 This Constitution may be amended from time to time by the Bishop-in-Council. either at the request of the Commission, the Management Committee, or the initiative of the Bishop-in-Council.
- 16.2 This Constitution took effect on 26th June 2014 pursuant to The Lismore Parish Centre Pre School Constitution Ordinance 1989 Amending Ordinance 2014.

16.3 This Constitution was amended by The Lismore Parish Centre Pre School Constitution Ordinance 1989 Amending Ordinance 2019 which took effect on 21st February 2019."

COMMENCEMENT

9. This Ordinance shall come into effect upon receiving the assent of the Bishop.

SHORT TITLE

10. This Ordinance may be cited as the Lismore Parish Centre Pre School Constitution Amending Ordinance 2019.
