CLERGY STIPENDS, SUPERANNUATION and LONG SERVICE LEAVE

New Stipend levels

At its meeting of 8 October 2015, Bishop-in-Council resolved that the Australian Bureau of Statistics' Wage Price Index (WPI) will be the basis on which the clergy stipend is revised each year. As the WPI over the applicable 12 month period up to September 2019 was 2.2%, the following schedule of clergy stipends will be effective from 1 January 2020.

(Notes: 1 includes Priests-in-Charge and Locums; 2 typically a senior priest in a challenging role; 3 typically a priest in a curacy or training stage; 4 Stipendiary deacons only)

Superannuation

The rate of superannuation for clergy will remain at 10.5% of the stipend. (Superannuation will not be applied to the payment of allowances.)

Long Service Leave

The Anglican Church of Australia Long Service Leave Fund has advised that the annual rate of contribution for a full-time participant in the fund will become \$1,596.00 from 1 January 2020.

Future changes to Stipend

As mentioned above, the Wage Price Index (WPI) statistic provided by the Australian Bureau of Statistics will guide future increases in clergy stipend. The stipend will change on 1 January of each year depending on the annual change in the WPI reported in the previous September Quarter. The September Quarter statistic is usually published in mid-November of each year.

DIRECTOR OF PROFESSIONAL STANDARDS

Effective on 9 September 2019, The Diocese of Grafton appointed Mr Phillip Bonser as Director of Professional Standards (DPS).

RENEWAL OF INSURANCE

The insurance policies for the Anglican Diocese of Grafton, its parishes and organisations run from 1 November through to 31 October. The arrangements for insurance cover from 1 November 2019 are being finalised and we expect that during December we will be adding the certificates of currency to the Diocese's website and invoicing parishes and organisations for their share of the insurance costs.

At this point of time, we have not been advised of what our insurance premiums will be but we are hearing that hefty increases in property insurance are happening around the country. The worst stories come out of North Queensland where property insurance increases of over 500% have been reported. Although we are not in the same zone, and our premium increases are unlikely to be the same, the insurance industry is planning for higher catastrophe costs.

CCLI LICENCE RENEWAL

In the next few weeks, each parish will be contacted by the Registry seeking information for the renewal of CCLI copyright licences. Your assistance is requested in responding in full as soon as you can so that parishes can have the proper level of licence cover.

It is important to remember that CCLI licences do not cover all of the hymns and worship songs used in churches. If further licences are required for material that is not covered by CCLI, parishes should organise that independently according to their needs.

POLICIES & PROCEDURES

Since the last Registry Update in March 2019, there has been a new procedure and several updated or reviewed procedures.

MUP-005 Parish Delegations is a new procedure clarifying what actions can be taken on behalf of the Corporate Trustees of the Diocese of Grafton at a parish level. This procedure

was introduced after the June 2019 Synod approved changes to Chapter 10 Parish Administration of the Diocesan Governance Ordinance.

It is important that each Rector, Churchwarden and Treasurer is familiar with both Chapter 10 and MUP-005.

Other policy and procedure documents that were reviewed and updated are:

- GEN-001 Privacy (A small number of amendments was made to this policy)
- GEN-006 Background Checks and Minimum Training Standards for Community Protection (This procedure has been updated to include Safe Ministry Checks and includes the various Safe Ministry Check forms)
- MUP-002 Clergy Housing (This procedure was reviewed but not changed)
