

**THE GRAFTON ANGLICAN SCHOOLS CONSTITUTIONS AMENDING  
ORDINANCE 2020  
Ordinance No. 2 of 2020**

An ordinance to amend the Constitutions of each of the Anglican Schools of the Diocese of Grafton.

**PREAMBLE**

**Whereas** the Constitution of Bishop Druitt College is contained in the Schedule of The Bishop Druitt College Constitution Ordinance 1992 Amending Ordinance No. 2 2016;

**Whereas** the Constitution of Clarence Valley Anglican School is contained in the Schedule of The Cathedral School Constitution Ordinance 1997 Amending Ordinance No. 2 2016;

**Whereas** the Constitution of Emmanuel Anglican College is contained in the Schedule of The Emmanuel Anglican College Constitution Ordinance 1997 Amending Ordinance No. 2 2016;

**Whereas** the Constitution of Lindisfarne Anglican Grammar School is contained in the Schedule of The Lindisfarne School Constitution Ordinance 1989 Amending Ordinance No. 2 2016;

**Whereas** the Constitution of St Columba Anglican School is contained in the Schedule of The Port Macquarie Anglican School Constitution Ordinance 2000 Amending Ordinance No. 2 2016;  
and

**Whereas** it is desirable to have each of these Constitutions amended to remove the requirement to advise the Bishop prior to the consideration of a resolution made outside of a meeting of school council;

**Therefore**, the Bishop-in-Council in pursuance of powers provided in clause 48.2 of the Diocesan Governance Ordinance 2008 hereby decrees and enacts as follows:

**AMENDMENTS**

1. The amendments listed in clauses 2 to 6 inclusive of this Amending Ordinance are to apply to the Constitution of each of Bishop Druitt College, Clarence Valley Anglican School, Emmanuel Anglican College, Lindisfarne Anglican Grammar School and St Columba Anglican School.
2. Amend clause 6.7.3 of the Constitution by deleting the words “to the Bishop and”.
3. Amend clause 6.7.12.1 of the Constitution by deleting the words “and the Bishop”.

Amendment History

4. Insert a new sub-clause 15.5 into the Constitution as follows:

“This Constitution was amended by Anglican Schools Constitution Amending Ordinance 2020 which took effect on 6<sup>th</sup> February 2020.”

**COMMENCEMENT**

5. This Ordinance shall come into effect upon receiving the assent of the Bishop.

**SHORT TITLE**

6. This Ordinance may be cited as the Anglican Schools Constitution Amending Ordinance 2020.


