

**THE GRAFTON ANGLICAN SCHOOLS CONSTITUTIONS AMENDING  
ORDINANCE No. 2 2020  
Ordinance No. 10 of 2020**

An ordinance to amend the Constitutions of each of the Anglican Schools of the Diocese of Grafton.

**PREAMBLE**

**Whereas** the Constitution of Bishop Druitt College is contained in the Schedule of The Bishop Druitt College Constitution Ordinance 1992 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020;

**Whereas** the Constitution of Clarence Valley Anglican School is contained in the Schedule of The Cathedral School Constitution Ordinance 1997 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020;

**Whereas** the Constitution of Emmanuel Anglican College is contained in the Schedule of The Emmanuel Anglican College Constitution Ordinance 1997 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020 ;

**Whereas** the Constitution of Lindisfarne Anglican Grammar School is contained in the Schedule of The Lindisfarne School Constitution Ordinance 1989 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020;

**Whereas** the Constitution of St Columba Anglican School is contained in the Schedule of The Port Macquarie Anglican School Constitution Ordinance 2000 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020; and

**Whereas** it is desirable to have each of these Constitutions amended to provide powers to each school council to establish a deductible gift recipient fund to further the purposes of the school;

**Therefore**, the Bishop-in-Council in pursuance of powers provided in clause 48.2 of the Diocesan Governance Ordinance 2008 hereby decrees and enacts as follows:

**AMENDMENTS**

1. The amendments in clauses 2 and 3 of this Amending Ordinance are to apply to the Constitution of each of Bishop Druitt College, Clarence Valley Anglican School, Emmanuel Anglican College, Lindisfarne Anglican Grammar School and St Columba Anglican School.
2. Insert the following as clause 5.5.8 and renumber the existing clause 5.5.8 as 5.5.9:  
“The Council may create one or more Australian Taxation Office endorsed tax-deductible gift recipient funds such as a Building Fund, Library Fund, Scholarship Fund, Public Ancillary Fund or other tax-deductible fund, to assist in furthering the aims and objectives of the School.”

Amendment History

3. Add to Section 15 of the Constitution as follows:

“This Constitution was amended by Anglican Schools Constitution Amending Ordinance No. 2 2020 which took effect on 16<sup>th</sup> July 2020.”

**COMMENCEMENT**

- 4. This Ordinance shall come into effect on 16<sup>th</sup> July 2020.

**SHORT TITLE**

- 5. This Ordinance may be cited as the Anglican Schools Constitution Amending Ordinance No. 2 2020.


