

**THE GRAFTON ANGLICAN SCHOOLS CONSTITUTIONS
AMENDING ORDINANCE 2022
Ordinance No. 15 of 2022**

An ordinance to amend the Constitutions of each of the Anglican Schools of the Diocese of Grafton.

PREAMBLE

Whereas the Constitution of Bishop Druitt College is contained in the Schedule of The Bishop Druitt College Constitution Ordinance 1992 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020, The Grafton Anglican Schools Constitutions Amending Ordinance No. 2 2020, and The Grafton Anglican Schools Constitutions Amending Ordinance 2021;

Whereas the Constitution of Clarence Valley Anglican School is contained in the Schedule of The Cathedral School Constitution Ordinance 1997 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020, The Grafton Anglican Schools Constitutions Amending Ordinance No. 2 2020, and The Grafton Anglican Schools Constitution Ordinance 2021;

Whereas the Constitution of Emmanuel Anglican College is contained in the Schedule of The Emmanuel Anglican College Constitution Ordinance 1997 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020, The Grafton Anglican Schools Constitutions Amending Ordinance No. 2 2020, and The Grafton Anglican Schools Constitution Ordinance 2021;

Whereas the Constitution of Lindisfarne Anglican Grammar School is contained in the Schedule of The Lindisfarne School Constitution Ordinance 1989 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020, The Grafton Anglican Schools Constitutions Amending Ordinance No. 2 2020, and The Grafton Anglican Schools Constitution Ordinance 2021;

Whereas the Constitution of St Columba Anglican School is contained in the Schedule of The Port Macquarie Anglican School Constitution Ordinance 2000 Amending Ordinance No. 2 2016 and amended by The Grafton Anglican Schools Constitutions Amending Ordinance 2020, The Grafton Anglican Schools Constitutions Amending Ordinance No. 2 2020 and The Grafton Anglican Schools Constitution Ordinance 2021; and

Whereas it is desirable to have each of these Constitutions amended to remove any doubt surrounding the approvals required by each school relating to real property.

Therefore, the Bishop-in-Council in pursuance of powers provided in clause 48.2 of the Diocesan Governance Ordinance 2008 hereby decrees and enacts as follows:

AMENDMENTS

1. The amendments in clause 2 of this Amending Ordinance are to apply to the Constitution of each of Bishop Druitt College, Clarence Valley Anglican School, Emmanuel Anglican College, Lindisfarne Anglican Grammar School and St Columba Anglican School.

2. Replace subclause 5.4.3 with the following.

"The Council may:

- a) purchase, lease or otherwise acquire rights in real property; and*
- b) sell, mortgage, exchange, lease or otherwise dispose of rights in real property*

for the purposes of the School provided that it has first obtained the written approval of the Bishop-in-Council."

VALIDITY OF PREVIOUS ACTIONS

3. The amendment to the constitution of each school as above shall not render invalid any previous real property transaction that was conducted in accordance with the constitution at the time.

COMMENCEMENT

This Ordinance shall come into effect upon receiving the Bishop's assent.

SHORT TITLE

This Ordinance may be cited as the Anglican Schools Constitution Amending Ordinance 2022.

ASSENT
