DIOCESAN CONFERENCE

On Saturday 5 and Sunday 6 November, the Diocese is holding a conference "Resourcing Parish Leadership". This conference to be held at Opal Cove, Coffs Harbour is open to all interested Anglicans from across the Diocese. It will be especially valuable to members of Parish Council, Parish Treasurers and Grievance Officers.

The keynote speaker for the conference is Bishop Bradly Billings from the Anglican Diocese of Melbourne. Bishop Brad is well known for his expertise in church governance at a practical level and heads a list of knowledgeable speakers.

COVID SAFETY AND VACCINATIONS

COVID-19 is still with us; but circumstances are continuing to evolve.

Last year, the Bishop-in-Council decided to make vaccinations for COVID-19 compulsory for many ministry roles across the Diocese. That policy was spelled out in GEN-012 Vaccination for COVID-19.

However, Bishop-in-Council has now resolved to withdraw GEN-012 Vaccination for COVID-19.

The Bishop-in-Council resolution of 1 September 2022 is:

"That Bishop-in-Council rescinds the policy/procedure document GEN-012 Vaccination for COVID-19 and encourages those in active ministry to consider mitigating the risk of infecting vulnerable people with COVID-19 through the use of ventilation, masks, hand sanitisation, social distancing and Rapid Antigen Testing. Despite the rescission of a policy that requires vaccination, Bishop-in-Council continues to encourage those in active ministry remain up to date with a full course of vaccination against COVID-19 as defined by the Australian Technical

Advisory Group on Immunisation, except where they have received medical advice to not be vaccinated."

Although, vaccination is no longer compulsory, the following remain important:

- Vaccination for COVID-19 is still considered a good safety measure and is encouraged, except for those who have received medical advice not to be vaccinated;
- Vaccination for COVID-19 may be a requirement in some settings (e.g. some health care locations);
- The risk to vulnerable people should be considered when undertaking ministry and church activities.
- Risk can be reduced through a combination of the following:
 - Isolation if infected with COVID-19 or displaying symptoms
 - Rapid Antigen Testing (RAT)
 - Good ventilation
 - Masks
 - Hand hygiene
 - Social distancing

The Anglican Diocese of Grafton has received a supply of Rapid Antigen Tests (RAT) which are being provided to each parish and ministry district to assist with limiting the spread of COVID-19. If your parish is yet to receive a supply of RATs, please contact admin@graftondiocese.org.au

Finally, although GEN-012 Vaccination for COVID-19 is no longer valid, any records taken for that procedure should be retained and kept secure.

MINISTRY TRAVEL AND REIMBURSEMENT

The procedure MUP-003 Ministry Travel and Associated Expense Reimbursement gives details relevant for those travelling or driving vehicles as part of their ministry or in their church role. The procedure also includes the approved rates of reimbursement.

Bishop-in-Council has approved an amended form of MUP-003 Ministry Travel and Associated Expense Reimbursement which is now available on the Diocesan website at https://www.graftondiocese.org.au/documents/policies-procedures/

The following table shows the change to reimbursement rates that is effective from 1 January 2023.

Rates for reimbursement for motor vehicle use	Current rate	New rate – effective from 1 January 2023
Use of private vehicle as a requirement of role	Fixed component: \$8,000 pa Variable component: 26 cents per kilometre	Fixed component: \$9,200 pa Variable component: 30 cents per kilometre
Occasional use of private vehicle	Fixed component: Nil Variable component: 66 cents per kilometre	Fixed component: Nil Variable component: 78 cents per kilometre

GENERAL SYNOD - CLIMATE CHANGE

It is well known that the parishes and agencies of the Grafton Diocese take Climate Change seriously and act as and where they can as part of the 5th Mark of Mission "To strive to safeguard the integrity of creation, and sustain and renew the life of the earth".

This issue was also raised and supported at the General Synod meeting in May 2022 and the following resolution was passed.

In light of this resolution, each parish and agency is encouraged to further examine its contribution to climate change and consider further what can be done to mitigate climate change.

Climate Change – Call to the Church

That this Synod, A. Noting:

 Resolution A17:05 of the Anglican Consultative Council (ACC) 2017, in which the ACC recognised that there is a Climate Emergency and called on member churches to respond in ways that are 'a living testament to our faith';
Resolution A17:06 of the ACC 2017, in which the ACC called upon member churches to work towards building climate resilience; 3. That the 2020 meeting of the General Synod of The Church of England (C of *E*) called on 'all parts of the C of *E* ..., to work to achieve year-on-year reductions in emissions and urgently examine what would be required to reach net zero emissions by 2030 in order that a plan of action can be drawn up to achieve that target'.

4. With concern, the lack of progress in the Anglican Church of Australia in reporting on the Protection of the Environment Canon 2007 and reporting on the calculation of emissions as requested in R62/17.

B. Recognises that the global climate emergency is a crisis for God's creation, and a fundamental injustice, which ultimately stems from rebellion against our Creator and his commands to humans regarding stewardship of his world.

C. Trusts Jesus Christ as ultimate reconciler of all things in creation, through his blood shed on the cross and looks with hope to his promise of a renewed creation.

D. Encourages consideration of the actions involving worship, mission, advocacy, and community participation commended to the Church in ACC 2017 Resolutions A17.05 and A17.06.

E. Encourages the Diocese and Agencies of the Anglican Church of Australia to work towards net zero carbon emissions by 2040, and to consider faster reductions where possible.

F. Urges the Dioceses and Agencies of the Anglican Church of Australia to:

1. Strengthen their efforts to report on the Protection of the Environment Canon 2007;

2. Submit their best estimates of carbon emissions on an annual basis to The Standing Committee to enable us as a Province to track our progress toward net zero carbon emissions; and

3. Embrace the actions commended to the Church through ACC 2017 Resolutions A17.05 and A17.06, considered the most appropriate to their contexts.

TRUST INVESTMENTS

Parish Treasurers will have recently noticed that the quarterly statements of trust funds have shown some significant declines in trust balances. This contrasts with 2021 when trust balances were showing healthy increases.

This movement of trust fund values reflects the changing value of investments and is obvious at the moment while investment markets have been volatile.

Is this a cause for worry? As this is part of a market cycle there is no need to panic because the market will eventually regain its value and investments have been chosen to meet an average investment performance of CPI + 3% over a 5 year cycle.

The Corporate Trustees are carefully managing cashflow to avoid cashing in investments while at a low point in the cycle.
