THE ANGLICARE NORTH COAST ORDINANCE 2014 AMENDING ORDINANCE 2023 Ordinance No. 11 of 2023

An Ordinance to amend the constitution of Anglicare North Coast such that winding up provisions are in compliance with its obligations as a Community Housing Provider.

PREAMBLE

Whereas the constitution of Anglicare North Coast is set by The Anglicare North Coast Ordinance 2014; and

Whereas as a Community Housing Provider, Anglicare North Coast is required to have certain wind up provisions in its constitution;

Therefore, the Bishop-in-Council in pursuance of powers provided in clause 48.2 of the Diocesan Governance Ordinance 2008 hereby decrees and enacts as follows:

AMENDMENTS TO THE ANGLICARE NORTH COAST ORDINANCE 2014

- 1. Insert the following new clauses into 4.1 Definitions while maintaining the alphabetical order of definitions.
 - "Community Housing Asset has the same meaning given to the term in the Appendix to the Community Housing Providers (Adoption of National Law) Act 2012 (NSW), as amended or replaced."
 - "Housing Agency has the same meaning given to the term in the Appendix to the Community Housing Providers (Adoption of National Law) Act 2012 (NSW), as amended or replaced."
 - "National Law means Community Housing Providers (Adoption of National Law) Act 2012 (NSW)."
 - "Participating Jurisdiction has the same meaning given to the term in the Appendix to the Community Housing Providers (Adoption of National Law) Act 2012 (NSW), as amended or replaced."
- 2. Replace clause 7.1(b) with the following.
 - "Notwithstanding any other provision in this Constitution, if, on the winding up or dissolution of Anglicare North Coast, any property or asset remains that is a Community Housing Asset in a Participating Jurisdiction, it shall be transferred to one of the following in the jurisdiction where the Community Housing Assets are located, as determined by the Board at or before the time of dissolution subject to the approval of the Bishop-in-Council:
 - (i) the appropriate Housing Agency prescribed by the National Law, or
 - (ii) another Registered Community Housing Provider."
- 3. Amend clause 7.1(c) by replacing "Subject to (a)" with "Subject to (a) and (b)"
- 4. Amend clause 31.6(c) by replacing "31.5(a)" with "31.6(a).

COMMENCEMENT

This Ordinance shall come into effect upon receiving the assent of the Bishop.

SHORT TITLE

This Ordinance may be cited as the Anglicare North Coast Amending Ordinance 2023.
